Setup: The building will open by 7am all days for exhibitors

Check-in: Those exhibitors who indicated no need for measurements and have no other special check-in requirements should simply check in on the ringside gate sheets, observing COVID protocols. Please also check for posted "Refund Due" sheets to see whether you need to pick up a refund check.

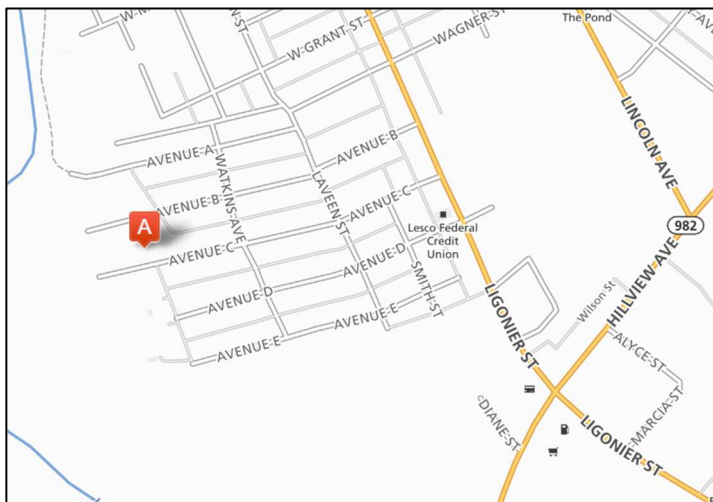
Measuring: Neither judge this weekend is a VMO. Unless an AKC Rep or other VMO magically appears, due to the AKC COVID policies no other measuring will take place at this trial.

Schedule (all times are only approximate after the start of the day!)

- Height order all days: **24→4**
- STD & JWW: All subdivisions will run together by height, within each skill level
- M/E STD/JWW will be split into **4 walkthroughs (24+20; 16; 12; 8+4)** minimum.
- M/E FAST likely will NOT be split at this trial but could be walk-walk-all run. T2B, Premier, and Nov/Op STD/JWW/FAST will not be split by height.
- **IF YOU THINK YOU MIGHT HAVE A WALK CONFLICT** –PLEASE WALK &/or RUN WITH AN **EARLIER** HEIGHT! (or be prepared for a public flogging...)
- **IF YOU THINK YOU NEED TO MOVE A DOG** – please check with the Trial Secretaries or Judge before moving a dog. Dogs have been pre-spaced out to the maximum possible, while remaining equally fair to everyone in the class. Only clear-cut instances that meet AKC's conflict criteria will be considered (i.e ring-to-ring conflicts). PLEASE PLAN AHEAD to try to eliminate/resolve conflicts well in advance to avoid last-second panic!

Show Site Info and Directions (B&D Creekside, 501 Avenue B, Latrobe, PA 15650):



Directions to B&D:

From US-30 or further South: head towards Latrobe; take PA-982 North for 1 mile from US-30. Turn left onto Ligonier St, go 0.3 miles. Turn left onto Avenue B, drive 0.4 miles to reach B&D.

From US-22 or further North: head towards New Alexandria; take PA-981 South for 6.5 miles from US-22. Turn RIGHT onto Industrial Blvd (PA-981S), go 0.5mi. Turn LEFT onto Lincoln Ave & go 0.6mi. Turn RIGHT onto James St, for 0.1 mi. Turn LEFT onto Ligonier St, & go 0.6mi to Avenue B. Turn RIGHT onto Ave B & drive 0.4 miles to reach B&D.

Indoor restrooms are available at the show site.

Overnight RV parking & camping at the show site is permitted; however there is NO dumping permitted. Reservations are taken on a first-come basis; a limited number of spaces are available. Reservation forms are available in the premium list.

FOOD: There will be food available at the show site! In addition, various restaurants are nearby - you may also bring in food for yourself this year!

But please, no shared/group food, except as specified within the Revised AAKA COVID Guidelines.

VOLUNTEERS: please help if you are available! Workers raffle tickets will be provided to all volunteers. There will be a signup board at the trial, or contact Darlene Ormsby at 814-932-5650 or Dormsby2@atlanticbb.net in advance

CRATING: Tent/EZ-Up &/or Car Crating is encouraged to assist with social distancing. Exhibitors will have access to the building **Friday at 1pm ONLY** if helping with setup; otherwise, crates may be set up from **4-7pm**. Do NOT set up crates before then, or they may be removed! Please be considerate

and use only the minimum space you need to ensure room for everyone and to maintain social distancing. X-pens allowed for VERY large or multiple dogs only. A waterproof tarp or mat must be placed underneath crates. Crates may be left overnight; however, neither AAKA nor B&D will be responsible for loss or damage of items left at the show site. ***** Please be aware that every night the equipment in the ring area may be misted with a disinfectant of water and bleach. It is your responsibility to decide whether to leave your crates in the building overnight*****

Please clean up after your dogs! Exhibitors failing to clean up after their dog(s) may be excused without refund if the Trial Committee deems the exhibitor to be in violation of this requirement. Cleaning and pick-up supplies and disposal sites will be available at several locations on the show grounds.

AAKA, INC. MAY 2021 COVID-19 GUIDELINES – Revised April 19, 2021

AAKA, Inc. is excited to hold its May 2021 agility trials at B&D Creekside Activity Center in Latrobe PA. We hope to have a fun agility weekend and know that we can count on you to make sure these guidelines are followed to ensure the continued safety and health of everyone attending our trials.

Please do NOT attend this trial: (a) if you were exposed to Covid-19 within 10 days preceding the trial and do not have a confirmed negative result from testing done 5+ days after the exposure. (b) if you have COVID-19 or its symptoms at the time of the trial. If any of these conditions apply to you or if you feel ill in any way during the trials, please contact the Trial Secretary if you wish to request a full refund for any runs not yet completed.

We have revised the following guidelines, which are based on updates to the AKC Best Practices for the Well-Being of Dog Sport Participants, and the latest PA and CDC guidelines. Any changes will be communicated as soon as possible before the trial weekend. If you can't comply with any of the changes, please contact the Trial Secretary prior to the trial to withdraw and request a refund.

These guidelines also apply to anyone attending with you or assisting at the trials, and they may be asked to leave if unwilling to comply.

1. **MASKS:** An appropriate face covering **MUST** always be worn in the building, including **WHILE RUNNING**. Masks must be worn correctly, covering both nose and mouth at all times. No exceptions/exemptions. Please bring your own face mask that fits correctly and stays in place while running (or bandana/gaiter that drapes to the neck/shoulder line; no face shields only). You do not need to wear a mask when outside the building as long as you maintain social distancing.
2. **GLOVES:** Bring disposable gloves or some type of glove if you want gloves.
3. **CHAIRS:** Bring your own chairs. B & D chairs will not be available for general use. The normal bleachers are folded and put away. They will not be in use.
4. **FOOD:** The on-site restaurant will be open on a limited basis with a simplified lunch menu. *** Please do NOT bring in shared food or MACH/PACH cakes unless they are individually portioned and/or will be served by a single server who will take appropriate sanitary and PPE measures. ***
5. **WASH HANDS:** Practice personal hygiene frequently and thoroughly. Use hand sanitizers positioned throughout the building and try to bring your own. Avoid touching dogs that are not your responsibility.
6. **SANITIZATION:** All equipment and surfaces have been thoroughly cleaned and sanitized. Please bring your own cleaning and sanitizing supplies. There will be a limited amount available at the trial. We will clean commonly touched surfaces regularly throughout the trial and again at the end of the day.
7. **ONE-WAY DOORS-TRAFFIC FLOW:** Doors **MAY** be marked with "ENTER" and "EXIT" signs. Please respect social distancing when entering and exiting the building.
8. **COURSE BUILDERS/RING CREW WORKERS:** Anyone setting up rings and changing bar heights must sanitize their hands frequently before and after setting up and while working in the ring, and may also choose to wear gloves if desired for additional self-protection. (Gloves, wipes, and hand sanitizer provided on scribe table). Social distancing will apply between scribe and timer. At end of the class, the timer will wipe down the timer box.
9. **CHECK IN BOARDS:** Please check in on the gate boards at the early check-in location or at ringside in advance of the class starting, using your own pen or by sanitizing and using a "public" pen. Once a class has started, if you need to check in on a board in use at ringside, please only ask the Gate Steward to check you in and/or move any of your dogs if needed to avoid conflicts. Please remember to maintain social distancing while checking in.
10. **LEASHES/LEASH RUNNER:** We encourage exhibitors to tuck their leash into a pocket or wear it securely on their person (i.e., clip it like a belt around your waist so no part is hanging) when running the course. If you opt to drop your leash, the leash runner may wear gloves or pick the leash up with a paper towel or hand grabber to transport it to the exit location.
11. **ENTERING AND EXITING RING:** We encourage you to use your hip to push the gates to enter/exit the ring. The gate tops will be wiped off after each class. Hand sanitizer will be available after your run.

12. **COURSE MAPS, BRIEFINGS, RUN ORDERS, AND RESULTS:** Documents will be posted in several areas to help with social distancing. Please snap camera/phone pictures of the maps and results as paper handouts will NOT be available. ONLINE MAPS, BRIEFINGS, and RUN ORDERS, barring any “technical problems” or time constraints (NOT “guaranteed”), will be posted by the Trial Secretary each evening for the next day, no earlier than 6 PM. They can be downloaded from: www.aakaagilitytrial.com.
13. **WALK THROUGHS/BRIEFINGS:** Per AKC guidelines, walkthroughs will be limited to 25 people at most. Additional walk throughs will be added as needed to keep numbers and crowding down. We encourage everyone to be mindful of others, take turns, and maintain personal distance. There will be NO obsessive walk throughs and NO Mas/Ex briefings, which may be posted on www.aakaagilitytrial.com.
14. **RIBBONS/BARS AND GIFT:** There will be no self-serve ribbons. Stickered ribbons may be placed on a table for you to pick up or there may be a volunteer in this area to place your sticker on the Q ribbon (or give the sticker to you to put in your book if you prefer) and give you any ribbons you are to be awarded. *(Please do not return any ribbons once you have taken them.)* **GIFT:** Every dog entered in the trial will receive one complimentary gift for the weekend as stated in the premium. Choose the item you touch and please do not exchange it afterward. Please do not touch any ribbons or bars you are not taking. Please maintain social distancing while picking up items.
15. **CRATING:** Indoor crating has not been a problem during the last few trials. But crating in the building or the ability to sit with your crated dogs **may be limited** if stricter occupancy limits are mandated or if the trial were to fill. Six-foot social distancing will apply inside and outside for the entire weekend (including 6’ spacing between people from different “household/travel crating groups”). Please be aware that every night the equipment in the ring area may be misted with a disinfectant of water and bleach. This will be done with a handheld misting machine that will be kept pointed away from the crating area. It is your responsibility to decide whether or not to leave your crates and water bowls in the building overnight!
16. **TENT/EZ-UP OUTDOOR CRATING:** If weather permits, “tent crating” will be allowed **anywhere** on the grass, but not in the immediate potty area at the end of the building and not in the parking lots or concrete pad next to the equipment garage door! (Please not too close to the garage doors!) They may be left overnight at your own risk – neither B&D nor AAKA will be responsible for theft or damage due to weather.
17. **BUILDING OCCUPANCY CONTROL:** Only workers and exhibitors entered in the trial (and their essential assistants) should be in the building. We encourage you to leave non-essential family and friends at home unless necessary to help you during the trials. We need to keep occupancy to a minimum to facilitate distancing and to meet any mandated limits.
18. **AFTER COMPLETING YOUR RUNS:** Once your runs are over for the day, and if you are not scheduled to work, please take your dog/dogs and exit the building. This practice will help make social distancing easier for those still at the trial.
19. **VOLUNTEERS:** We hope you will continue to “work together” and help our trial run smoothly. We **NEED** and **WELCOME** your help and thank everyone who will volunteer to assist us!
